ARTICLES OF INCORPORATION

OF

MIDDLETON BUSINESS ASSOCIATION, INC.

KNOW ALL PERSONS BY THESE PRESENTS That we, JAMES C.
MITCHELL, MERLE SMITH, Leann SWIGERT, JIM CORTA and BILL
BLACKBURN, whose names are hereunto subscribed, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under and by virtue of the laws of the State of Idaho and we do certify that:

Section 1: The name of the proposed nonprofit corporation is MIDDLETON BUSINESS ASSOCIATION, INC.

Section 2: MIDDLETON BUSINESS ASSOCIATION, INC. shall be a nonprofit corporation as provided by the Idaho Nonprofit Corporation Act.

Section 3: The duration of the proposed nonprofit corporation shall be perpetual.

Section 4: The purposes of the nonprofit corporation are:

- (a) to promote trade, recreation, commerce, industry, farming, livestock pursuits and transportation in and around said community, and
