ARTICLES OF INCORPORATION

The undersigned, who are natural persons of full age and citizens and residents of the State of Idaho and the United State of America, for the purpose of forming a corporation under the laws of the State of Idaho, hereby certify and declare:

ARTICLE I

The name of this corporation shall be C & R, INC.

ARTICLES II

The purposes for which it is formed are:

To establish, purchase, lease as lessee, or otherwise acquire, to own, operate, and maintain, and to sell, mortgage, deed in trust, lease as lessor, and otherwise dispose of retail stores or departments therein; to buy, sell, trade, manufacture, deal in, and deal with goods, wares, and merchandise of every kind and nature, and to carry on such business as wholesalers, retailers, importers, and exporters; to acquire all such merchandise, supplies, materials, and other articles as shall be necessary or incidental to such business; to have any and all powers above set forth as fully as natural persons, whether as principals, agents, trustees, or otherwise; and, all lawful purposes for which corporations can be organized.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV
