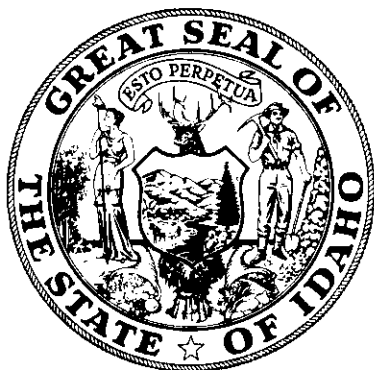

ARTICLES OF INCORPORATION
OF
KIDS KINDERGARTEN KRUSADE, INCORPORATED

KNOW ALL PEOPLE BY THESE PRESENTS:

That we, the undersigned, each being of legal age, a citizen of the United States of America, a resident of Meadows Valley, in Adams County, Idaho, have this day voluntarily associated ourselves together for the purpose of forming a non-profit association, pursuant to Chapter 3, Title 30, of the Idaho Code, to be known by the corporate name of "Kids Kindergarten Krusade, Inc." and for that purpose we do hereby CERTIFY THAT:

ARTICLE I

This corporation shall be known as the Kids Kindergarten Krusade, Incorporated.

ARTICLE II

The registered office and principal place of business of of said corporation is in New Meadows, Idaho in care of Meadows Valley School, North Commercial Avenue.

ARTICLE III

The duration of this corporation shall be perpetual.

ARTICLE IV

The incorporators of this incorporation will reside in Adams County.

ARTICLE V

The purposes and objects for which this corporation is formed are as follows:

To create, establish, and maintain an organized private kindergarten program at New Meadows, in Adams County, Idaho;

1. The primary purpose shall be to make provisions for teaching services, classroom facilities, and supplies for Meadows Valley kindergarten children.
2. To assist and cooperate with local school officials and other organized public bodies working for the educational betterment and improvement of the Meadows Valley children.
3. Do all and everything proper with the means and power of the corporation to provide and maintain every service and facility

- declared, given or paid to any member of this corporation from any income, earnings or property of the corporation.
8. Express condition upon which the foregoing, or any other, powers are conferred upon said corporation is that the activities and affairs of the corporation shall not be operated or conducted for profit or pecuniary gain of any of its members, and all income received by this corporation from any source what-so-ever in excess of the actual and necessary expenses and disbursements required for carrying on of the affairs of the corporation, shall be used for the sole benefit and advantage of the corporation in carrying out the purpose of the corporation.
 9. Adopt and use a corporate seal.
 10. Have all the foregoing statement and enumeration of powers as a reservation of power, and not a limitation or restriction of corporate powers, and in addition to the foregoing, this corporation shall have power to engage in every lawful enterprise, not inconsistent with the general purposes of the corporation, and do all and everything proper and necessary to be done in and about its property, affairs, and services, and to have, use, take and enjoy every right, power, privilege, and immunity by law conferred and granted to non-profit service organizations and volunteered services of its members.

ARTICLE VII

This corporation shall have no capital stock. It is to be governed and controlled by its members. The By-Laws of this corporation shall prescribe as to membership, directors, officers, meetings, projects, amending the By-Laws and responsibilities of members, directors and officers.

ARTICLE VIII

The following named persons, the incorporators hereof, are members of this corporation and shall have equal right and interest and become the initial board of directors, all residing in New Meadows, Idaho 83638.

Other persons who are interested in the work and purposes of this corporation may hereafter be admitted to membership upon such conditions and pursuant to such regulations as shall be prescribed by the By-Laws, and upon admission of such other persons they shall have equal rights and interest in the corporation with the above incorporators and all other members.


