The undersigned, as incorporators of the above corporation, adopt the following Articles of Incorporation for such corporation as follows:

ARTICLE I

Name. The name of the corporation is A-1 MERIDIAN MOVING AND STORAGE, INC.

ARTICLE II

Period of Duration. The period of duration of this corporation is perpetual.

ARTICLE III

Purpose. The purpose for which this corporation is formed is as follows: the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

Authorized Shares. The aggregate number and shares which the corporation shall have authority to issue, shall be One Thousand (1,000) shares of common stock with no par value.

No Shares Issued in Series. The corporation is not authorized to issue shares of any preferred or special class in series.


