We, the undersigned, hereby adopted the follow Amendments to the Articles of Incorporation of Isotropic Computer, Inc.
I.

The name of the corporation is currently Isotropic Computer, Inc.

TT.

The shareholders of the corporation have adopted a resolution to increase the total authorized number of par value shares of stock from 1,000 to 225,000. Article V of the Articles of Incorporation is therefore amended to read as follows:

"The total authorized number of par value shares of stock is 225,000. The par value of each authorized share shall be 10¢, and the aggregate par value of the total authorized number of par value shares is therefore \$22,500.00. There are no shares without par value".

III.

The date of adoption of this Amendment is the 24th day of January, 1984.

IV.

The number of shares outstanding of Isotropic Computer, Inc., is one thousand (1,000). There is only one class of shares of stock of Isotropic Computer, Inc. All one thousand (1,000) shares are entitled to vote on the adoption of Amendments.
