ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a non-profit corporation under the Idaho non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the Corporation is CHILD CARE CHOICES, INC.

ARTICLE II

The Corporation shall be a non-profit corporation.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The purposes for which the Corporation is organized are as follows:

- A. To promote the maintenance, development, and effectiveness of Resource and Referral services through coordination, direct services, and the sharing of information in Kootenai County.
- B. To provide a voice to represent those with child care and other family needs and to articulate those needs to the public.

ARTICLE V

The membership of the Corporation shall be open to all who share the goals of the stated purposes and meet membership requirements as stated in the By-Laws.

ARTICLE VI

The provisions for the regulation of the internal affairs of the Corporation shall be contained in the By-Laws, which shall be duly adopted by the Board of Directors of the Corporation.

ARTICLE VII

The street address of the initial registered office of the Corporation and the name of its initial registered agent at such street address is as follows:

ARTICLE VIII

The number of directors constituting the initial Board of Directors of the Corporation shall be ten (10), and the names and addresses of the persons who are to serve as directors until their successors are elected and shall qualify are:

ARTICLE IX

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code of 1954.

ARTICLE X

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in

furtherance of the purposes set forth in Article IX hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954.

ARTICLE XI

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all of the assets of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954, as the Board of Directors Any such assets not so disposed of shall be shall determine. disposed of by the District Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XII

The name and address of each of the incorporators are as shown on Exhibit "A" attached hereto.
