We, THE UNDERSIGNED natural persons of the age of 18 years or more and residents of the State of Idaho, acting as incorporators under the Idaho Business Corporation Act, I.C. §30-1-101 et.seq. (hereinafter the "act") hereby adopt and proclaim the following Articles of Incorporation:

ARTICLE I

<u>Name</u>

The name of the corporation shall be Insure Bear Lake, Inc. (hereinafter "the Corporation").

ARTICLE II

Duration

The term for which the Corporation shall exist is perpetual.

ARTICLE III

<u>Purpose</u>

The purpose of the organization is to engage in all lawful business, including but not limited to sales of insurance products, and all activities associated therewith. Further, the Corporation shall be empowered to engage in all activities of any legal nature whatsoever which are reserved to corporations in the Idaho Business Corporation Act.

ARTICLE IV

Stock

All stock of the Corporation shall be of the same class, common, and shall have the same rights and preferences. Fully paid stock of the Corporation shall not be liable to any further call or assessment.

ARTICLE V

Pre-emptive Rights

the Board of Directors shall issue any unissued shares of the stock of the Corporation, it shall notify each shareholder of the proposed issuance and of the terms and conditions under which shares are proposed to be issued. For a period of thirty (30) days after the giving of such notice, any Shareholder shall have the right, on the same terms and conditions as are stated in the notice, to acquire such portion of the shares proposed to be issued as the shares held by such Shareholder bear to the total shares issued and outstanding at the time such notice is given. Such right shall be exercised by giving notice of such election to the Corporation at its registered office. If any Shareholder does not give notice of his or her election to acquire such shares within such thirty (30) day period, the shares may be issued to others, but only on terms and conditions no more favorable than the terms and conditions stated in the notice to the Shareholders. The Shareholders shall have pre-emptive rights to acquire treasury shares, shares issued in payment for property, tangible or intangible and real or personal, or shares issued in performing an incentive option granted to officers or employees of the Corporation or officers or employees of any subsidiary corporation.

Amendment

These Articles of Incorporation may be amended by the affirmative vote of a majority of the Shares entitled to vote on such amendment.

Shareholders' Rights

The authorized and treasury stock of the Corporation may be issued at such time and upon such terms and conditions and for such consideration as the Board of Directors shall determine.
