KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and for such purpose we make and sign the following articles, to-wit:

and we hereby certify

The name of said corporation is hereby declared to be ~~THE~~ PEOPLES TRANSPORTATION COMPANY.

That the purposes for which it is formed are,
To carry on and conduct a general freight and passenger transportation business on Lake Coeur d'Alene and all waters tributary thereto, or, on any other navigable water of the United States, or on the High Seas, and also to carry on and conduct and own a general steamboat and sail boat business and barge business, and also for the purpose of constructing and maintaining such general boat and barge business and of selling and renting, making, constructing and buying steam, sail and row boats of every kind, class and description and to build and maintain wharves, warehouses, tram ways and railroad switches for the proper conduct and the carrying on in connection with said business, and to buy and sell any and all lands that may be necessary for the legitimate purposes of said corporate business or otherwise.

That the place where the principal place of business of said Corporation is to be transacted shall be the Town of Coeur d'Alene, Kootenai County, Idaho, and with the powers to establish other branch places, if found necessary, for the purposes of carrying on the business of said Corporation.

That the term for which it is to exist is Fifty (50) Years, from and after the date of its incorporation.

That the number of Directors of said Corporation shall be Seven (7) and that the names and residences of those who

are appointed for the first year, or until the first general election of Directors by the Stockholders, as may be fixed by the By-Laws, are as follows, to-wit:

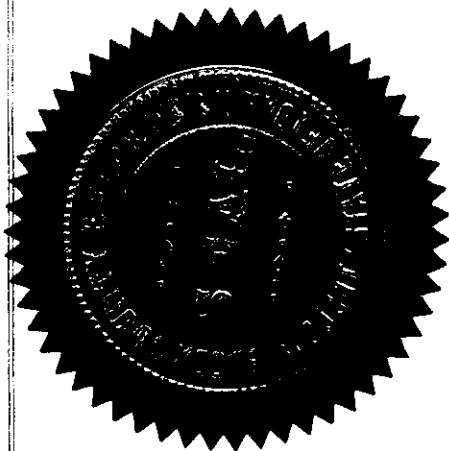
