ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is BECKER DIESEL & EQUIPMENT REPAIR, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of common shares, as defined by IRSC Section 1244, which the corporation shall have authority to issue is 3,000 at a par value of \$1.00 per share.

FIFTH: Provisions denying pre-emptive rights are none.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are as stated in the by-laws.

SEVENTH: The address of the initial registered office of the corporation is 6391 N. 5th West, Idaho Falls, Idaho 83401, and the name of its initial registered agent at such address is Daniel L. Becker.
