## CALDWELL KIWANIS YOUTH FOUNDATION, INC.

We, the undersigned, desiring to form a nonprofit corporation under the statutes of the State of Idaho, do hereby make, subscribe and acknowledge as follows:

#### ARTICLE ONE

## NAME

The name of the corporation is CALDWELL KIWANIS YOUTH FOUNDATION, INC.

#### ARTICLE TWO

## **PURPOSE**

The corporation is organized for the purpose of encouraging, promoting, and fostering the health, education, and welfare of young people living in the community of Caldwell, Idaho.

#### ARTICLE THREE

#### NONPROFIT PURPOSE

This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code. The corporation is formed exclusively for purposes which are not for ARTICLES OF INCORPORATION - 1

profit, and not for pecuniary profit or financial gain. No part of the corporate assets, income or profits shall be distributable to, or inure to the benefit of its officers, directors or members, except to the extent permitted for a nonprofit corporation under the nonprofit corporation laws of the State of Idaho and Section 501(c)(3) of the Internal Revenue Code. The corporation shall not take steps which serve to facilitate the transaction of specific business by its officers, directors, or members; or promote the private interest of any officer, director or member; or engage in any activity which would constitute a regular business of a kind ordinarily carried on for profit.

#### ARTICLE FOUR

## DURATION

The period of the duration of this corporation is perpetual.

#### ARTICLE FIVE

#### MEMBERS

There shall be no members. The Kiwanis Club of Caldwell, Inc., Post Office Box 925, Caldwell, Idaho 83606 shall have the authority to elect the directors of the corporation.

#### ARTICLE SIX
