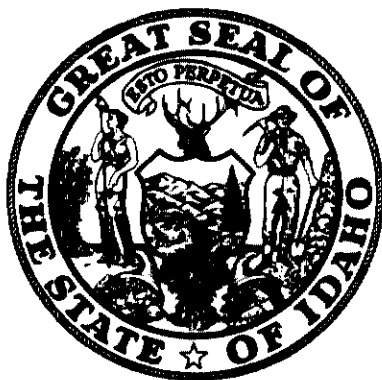
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, the undersigned, natural persons of full age, citizens and residents of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, particularly the Professional Service Corporation Act of Idaho, Idaho Code §30-1301, et seq., and do hereby certify as follows:

ARTICLE I.

The name of the Corporation shall be:

IDAHO ANESTHESIA, P.A.

ARTICLE II.

The Corporation is formed for the following purposes:

- (a) To provide professional anesthesia services, through certified registered nurse anesthetists;
- (b) To provide other health care services related to the primary purpose above stated, which services are lawful to be provided by certified registered nurse anesthetists;
- (c) To perform all lawful business activities, necessary or incidental to the foregoing purposes as permitted by the Idaho Professional Service Corporation Act, Idaho Code §30-1301, et seq.;

**ARTICLE III.**

The duration of the Corporation shall be perpetual.

**ARTICLE IV.**

The Corporation is authorized to issue one class of shares, in a total amount of 10,000 shares, each share of stock bearing a par value of \$10.00. Shares of stock of this Corporation shall not be transferred or sold until said sale shall be approved by the Board of Directors of this Corporation, in accordance with the duly adopted By-laws of this Corporation.

The Capital stock of this Corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued as fully paid shall be assessed or be assessable.


