ARTICLES OF INCORPORATION

- FIRST: The name of the corporation is to be Star Fence, Inc.
- SECOND: This corporation is to have a perpetual existence. The principal office in the state of Idaho will be at 4600 1/2 Hatwai Rd in the city of Lewiston, in Nez Perce County. This corporation may maintain an office or offices within or without the State of Idaho as may be needed from time to time designated by the Board of Directors.
- THIRD: Objects for which the corporation are formed are as follows: the transaction of any or all lawful business for which corporations may be incorporated under this act.
- FOURTH: The aggregate number of shares which this corporation shall have the authority to issue will be 10,000 shares and these shares will exist of one common class only, and shall have a par value of \$10.00 each share. Said Shares shall have equal voting rights of one vote per share, have no preferences, limitations, or relative rights, and may be issued from time to time by the corporation for consideration as may be fixed by the Board of Directors.
- FIFTH: There will be no pre-emptive rights denied to shareholders.
- SIXTH: There will be no provisions that are not inconsistent with law set forth in these Articles of Incorporation for the regulation of internal affairs of the corporation.
