FIRST: The name of the corporation is to be Star Fence, Inc.

SECOND: This corporation is to have a perpetual exsistence. The principal office in the state of Idaho will be at 46001/2 Hatwai Rd in the city of Lewiston, in Nez Perce County. This corporation may maintain an office or offices within or without the State of Idaho as may be needed from time to time designated by the Board of Directors.

THIRD: Objects for which the corporation are formed are as follows: the transaction of any or all lawful business for which corporations may be incorporated under this act.

FOURTH: The aggregate number of shares which this corporation shall have the authority to issue will be 10,000 shares and these shares will exsist of one common class only, and shall have a par value of \$10.00 each share. Said Shares shall have equal voting rights of one vote per share, have no preferences, limitations, or relative rights, and may be issued from time to time by the corporation for consideration as may be fixed by the Board of Directors.

FIFTH: There will be no pre-emptive rights denied to shareholders.

SIXTH: There will be no provisions that are not inconsistent with law set forth in these Articles or Incorporation for the regulation of internal affairs of the corporation.

ELEVENTH: This corporation reserves the right to amend it's Articles of incorporation from time to time in any, and as many respects as may be desired, so long as the Articles of Incorporation as amended contain only such provisions as might be lawfully contained in orginal Articles of Incorporation.
