Pursuant to the provisions of Idaho Code §53-663, the undersigned constituent business entities hereby adopt the following Articles of Merger, effective as of January 16, 2007, for the purpose of merging Southern Idaho Ambulatory Surgery Center, P.L.L.C., d/b/a Sawtooth Surgery Center, an Idaho professional limited liability company ("Surgery Center"), with and into SIASC Merger Company, LLC, a Idaho limited liability company ("Merger Company"):

1. The name and jurisdiction of formation or organization of each business entity which is to merge is:

2. An agreement and plan of merger has been approved and executed by each business entity that is a party to the merger.

3. The name of the surviving business entity is SIASC Merger Company, LLC (the "Surviving Company").

4. The merger shall become effective upon the filing of these Articles of Merger.

5. The agreement and plan of merger is on file at the principal place of business of the Surviving Company located at 115 Falls Avenue West, Twin Falls, Idaho 83301.

6. A copy of the agreement of merger will be furnished by the Surviving Company on request and without cost, to any person holding an interest in any business entity which is a constituent entity in the merger.

7. The Articles of Organization of Merger Company shall be the Articles of Organization of the Surviving Company, and upon the effectiveness of the merger, such Articles of Organization shall be amended to (i) change the name of the Surviving Company to "Southern Idaho Ambulatory Surgery Center, LLC," and (ii) list the name and address of at least one member of the Surviving Company, and such member shall be H. Peter Doble, 115 Falls Avenue West, Twin Falls, Idaho 83301.

8. The operating agreement of Merger Company in existence immediately prior to the merger shall be the operating agreement of the Surviving Company.
