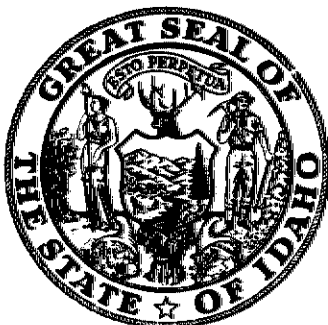

The undersigned, acting as incorporator(s) of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I  
NAME**

The name of the corporation is Cache Valley Plant & Produce Pavilion, Inc.

**ARTICLE II  
DURATION**

The period of its duration is perpetual.

**ARTICLE III  
PURPOSE**
