



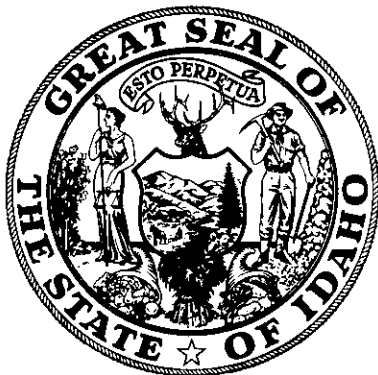
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
LEEMING CONSTRUCTION, INCORPORATED

The undersigned, acting as Incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE

NAME OF CORPORATION

The name of the corporation shall be LEEMING CONSTRUCTION, INCORPORATED.

ARTICLE TWO

PERIOD OF DURATION

The period of duration of the corporation shall be perpetual.

ARTICLE THREE

CORPORATE PURPOSES

The purpose for which the corporation is organized shall be any or all lawful purposes and business for which a corporation may be incorporated under the Idaho Business Corporation Act and the laws of the State of Idaho.

ARTICLE FOUR

AUTHORIZED SHARES OF STOCK

The aggregate number of shares of corporate stock which the corporation shall have authority to issue shall be One Thousand (1000) shares. All of such shares of corporate stock shall have a par value of Ten (\$10.00) dollars per share.

ARTICLE FIVE

NO PREEMPTIVE RIGHTS

There shall be no provisions granting preemptive rights to any class of stock or any stockholder.

ARTICLE SIX

BYLAWS REGULATE INTERNAL AFFAIRS

Provisions for the regulation of the internal affairs of the organization shall be set forth in the Bylaws of the corporation.

ARTICLE SEVEN

REGISTERED OFFICE AND AGENT

The name and address of the initial registered office of the corporation shall be LEEMING CONSTRUCTION, INCORPORATED, P.O. Box 2776, Sun Valley, Idaho 83353. The name and street address of the initial registered agent of the

corporation shall be Thomas Leeming, President, 104 Juniper, Sun Valley, Idaho 83353.

ARTICLE EIGHT

CORPORATE DIRECTORS

The number of Directors constituting the initial Board of Directors of the corporation shall be four (4), and the names and addresses of the persons who are to serve as Directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
