

ARTICLES OF INCORPORATION

of the

WESTERN MICA COMPANY.

KNOW ALL MEN BY THESE PRESENTS:

That we the undersigned a majority of whom are citizens and residents of the State of California have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the said State.

AND WE HEREBY CERTIFY:

1. That the name of the corporation is

THE WESTERN MICA COMPANY.

2. That the purposes for which it is formed are:

(A) To engage in the business of mining for and dealing in mica and other minerals and metals; to acquire mining claims mines machinery tools tramways patents trade-marks designs copyrights and any inventions necessary or convenient to be used in or about such business or relating to any of the various employments or arts connected therewith; and to carry on any employment or art connected with the business of mining for and dealing in precious metals.

(B) To purchase or otherwise acquire real estate for the purposes of the business of the corporation and the same to mortgage lease sell exchange or otherwise deal with or dispose of for the benefit of the corporation.

(C) In and about the business of the corporation to borrow or lend money; give or accept bonds or mortgages liens pledges or other securities; give or take leases; purchase sell exchange or otherwise deal with stock in other corporations; purchase hold sell exchange or otherwise deal with any other property real or personal; and generally to undertake and carry into effect any and all manufacturing financial commercial trading shipping or other operations for which individuals may lawfully associate themselves.

3. That the place where its principal business is to be transacted is the City and County of San Francisco State of California.

4. That the term for which it is to exist is fifty years from and after the date of its incorporation.
