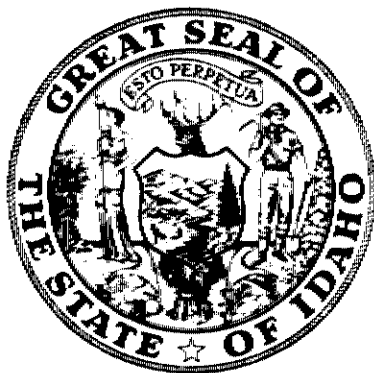

ARTICLES OF AMENDMENT

OF

The undersigned, its President and Secretary whom are its sole shareholders and directors, adopts the following Articles of Amendment for such corporation
