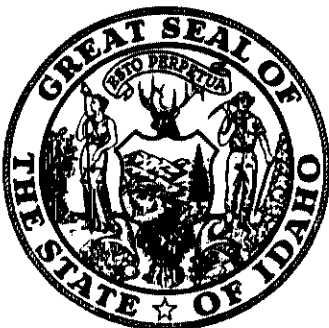
### CERTIFICATE OF INCORPORATION OF

ARTICLE I
