



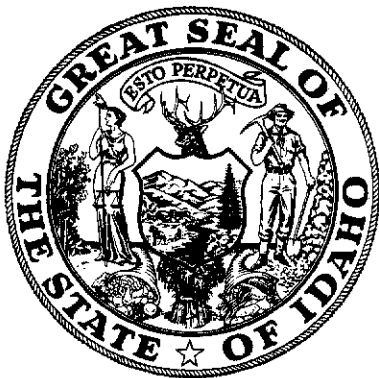
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

THIS IS TO CERTIFY that we, the undersigned, hereby incorporate
pursuant to the Laws of the State of Idaho providing for
the formation of corporations for profit, for the purposes and with the
powers hereinafter stated.

I

The name of this corporation is:

II

THE GENERAL NATURE and purpose of the business of the business of this
corporation shall be the operation of a publishing company and the performance
of any and all activities generally associated thereto; and also

To engage in any activity or business permitted under the Laws of
the United States and of this State.

The existence of this corporation is to be perpetual.

The amount of capital which this corporation shall commence business shall be no less than Five Hundred Dollars (\$500.00).
