SECOND ARTICLES OF AMENDMENT  
SECRETARY OF  
STATE  
TO

CAPITOL YOUTH SOCCER ASSOCIATION, INC.

The undersigned, being a majority of the voting members of the Capitol Youth Soccer Association, hereby state as follows:

1. The name of the non-profit corporation is the Capitol Youth Soccer Association, Inc.

2. On April 9, 1984, the undersigned deleted the original Article VIII (Article of Incorporation dated April 30, 1980) and substituted and adopted the following amendment to the Articles of Incorporation:

Article VIII Liquidation Distribution

At the end of the term of the corporation or in the event of dissolution prior to the end of the term, if there shall be any balance of assets and funds of the corporation after the payment or provision for all debts of the corporation and the necessary expenses of liquidation, the Board of Directors in their discretion shall distribute such remaining assets and funds, to Boise Independent School District for a public use.

3. As of April 9, 1984, there were fourteen voting members entitled to vote on this amendment to the Articles. All voting members, being a majority, have agreed to the foregoing amendment.


