

ARTICLES OF INCORPORATION
OF
ST. JOHN VIANNEY SOCIETY, INC.

- FIRST: The name of this Corporation shall be St. John Vianney Society, Inc.
- SECOND: This corporation is a public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Corporation Law of the State of Idaho, exclusively for charitable, religious and educational public benefit purposes.
- THIRD: The specific purpose for which the corporation is organized is to be an apostolate of Christ's Holy Church in Idaho, to promote and support the formation and education of young men studying for the ordained priesthood; and the transaction of any lawful activity.
- FOURTH: The street address of the registered office is: 3314 Tucker Road, Boise, Idaho 83703, and the registered agent at this address is: MaryLou Molitor
- FIFTH: The names and addresses of the initial directors are:

- SIXTH: Registered Agent: MaryLou Molitor, 3314 Tucker Road, Boise, ID 83703
- SEVENTH: The corporation will not have voting members.
- EIGHTH: A. This corporation is organized and operated exclusively for charitable, religious and educational purposes under and within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986.
B. No substantial part of the activities of this corporation shall consist of carrying on legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of or in opposition to any candidate for public office.
C. Notwithstanding any other provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal incomes taxes under Internal Revenue Code (Section 501(c)(3) or (b) by a corporation contributions to which are deductible under Internal Revenue Code Section 170(c)(2), or corresponding provisions of any future U.S. Internal Revenue law.
- NINTH: The property of this corporation is irrevocably dedicated to charitable, religious and educational purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable and educational purposes in harmony with those of this organization, and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
