

ARTICLES OF INCORPORATION OF  
IDAHO CONSERVATIVE FORUM, INC.

The undersigned, acting as the incorporator of the nonprofit corporation organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code, adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of the Corporation is IDAHO CONSERVATIVE FORUM, INC.

ARTICLE II. NONPROFIT STATUS

The Corporation is a nonprofit corporation.

ARTICLE III. PERIOD OF DURATION.

The period of duration of the corporation is perpetual.

ARTICLE IV. INITIAL REGISTERED OFFICE AND AGENT.

The location of this Corporation is in the City of Coeur d'Alene, State of Idaho. the address of the initial registered office is 1424 Sherman Avenue, Suite 200, PO Box 3190, Coeur d'Alene, ID 83816. James P. Hannon, Attorney at Law is the initial registered agent for service of process.

ARTICLE V. PURPOSES

The purposes for which the Corporation is organized and will be operated are to educate and inform the citizens of the Great State of Idaho, and to insure that the workings of government in light of serious and important political issues are fully explained and understood. This Corporation is further authorized to exercise all powers granted by law necessary and proper to carry out the above-stated purposes, including but not limited to the power to accept the donations of money, property, whether real or personal, or any other thing of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefore, may not at that time lawfully carry on or do.

ARTICLE VI. LIMITATIONS.

The Corporation shall not carry on any other activities not permitted to be carried on by corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time.

## ARTICLE VII. MEMBERS.

The Corporation shall have no members.

## ARTICLE VIII. BOARD OF DIRECTORS.

The affairs of the Corporation shall be managed by its Board of Directors. The Board of Directors shall consist of not less than three (3) nor more than nine (9) individuals, each of whom, at all times, shall be a member of the Corporation. The actual number of Directors shall be fixed by the Bylaws of the Corporation. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the Directors shall be elected or appointed by the existing Directors in the manner and for the term provided in the Bylaws of the Corporation.

## ARTICLE IX. DISTRIBUTION ON DISSOLUTION.

Upon dissolution of the Corporation, the Board of Directors shall after paying or making provision for the payment of all liabilities of the Corporation, distribute all the assets of the Corporation consistent with the purposes of the Corporation to such organization or organizations as shall at the time qualify as exempt organizations under Section 501©(3) of the Internal Revenue Code of 1986, as amended from time to time, in such manner as the Board of Directors shall determine. Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations, as such court shall determine to be consistent with the purposes of the Corporation.

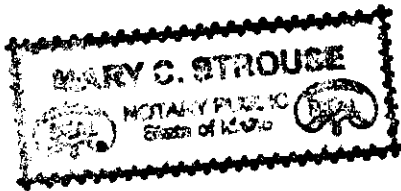
ARTICLE XI. BYLAWS.

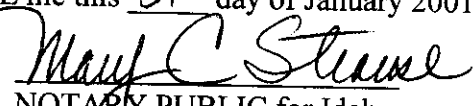
Provisions for the regulation of the internal affairs of the Corporation shall be set forth in the Bylaws.
