**ARTICLES OF INCORPORATION FOR**

**NORTH IDAHO ANESTHESIA ASSOCIATES, P.C.**

**UNDER TITLE 30, CHAPTER 13 OF THE PROFESSIONAL SERVICE  
CORPORATION ACT**

- I. The name of the Corporation is North Idaho Anesthesia Associates, P.C.
- II. The Corporation is organized pursuant to the provisions of Title 30, Chapter 13 of the Idaho Professional Service Corporation Act.
- III. The period of its duration is perpetual.
- IV. The corporation is a corporation for profit and is organized to engage in the practice of anesthesiology.
