
ARTICLES OF AMENDMENT OF THE
ARTICLES OF INCORPORATION OF
WHITE SAGE FARMS, INC.

Pursuant to a written consent executed by the shareholders of White Sage Farms, Inc. (hereinafter referred to as the "Corporation"), in lieu of a meeting of the shareholders of the Corporation, the Articles of Incorporation of the Corporation were amended to restate in its entirety Article VI of the Articles of Incorporation to read as follows:

"VI

"The capital stock of this corporation shall be divided into Seven Thousand Five Hundred shares (7,500), each having a par value of Ten Dollars (\$10.00) and having an aggregate par value of Seventy-Five Thousand Dollars (\$75,000.00). No distinction shall exist among the shares of this corporation, and all such shares shall have the same rights in the corporation. The shares of this corporation shall not be subject to assessment for any purpose whatsoever. The transfer of shares of stock of the corporation may be restricted in the manner and to the extent provided in the By-Laws."
