ARTICLES OF INCORPORATION

ARTICLES OF INCORPORATION

WE THE UNDERSIGNED, being natural persons of the age of 18 years or more and acting as the incorporators of a for profit corporation to be organized pursuant to the provisions of the Idaho Business Corporation Act, Title 30 Chapter 1 of the Idaho Code, do hereby adopt the following Articles of Incorporation:

Article I

The name of the corporation is Manwaring Enterprises, Limited.

Article II

The duration of the corporation is to be perpetual.

Article III

The corporation is formed for the following purposes:

- 1. To own and manage real property located in the State of Idaho for income from rents and leases of such property.
- 2. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

Article IV
