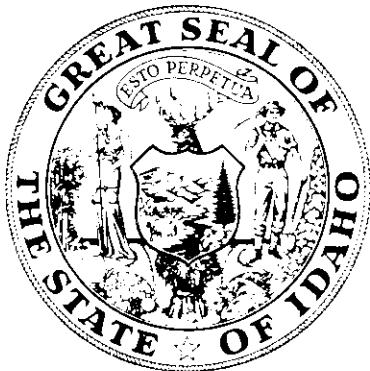

ARTICLES OF AMENDMENT

of

ARTICLES OF INCORPORATION

of

LEWISTON MANOR, INC.

We, the undersigned, President and Secretary of Lewiston Manor, Inc., a corporation created, organized and existing under and by virtue of the laws of the State of Idaho, do hereby certify:

That pursuant to the provisions of Section 30-1-58(a), the holders and owners of all the stock of Lewiston Manor, Inc., adopted the following amendment and at such time such time 393 shares were issued and outstanding with each share entitled to one vote. All of the shareholders and incorporators gave written consent and all outstanding stock was affirmatively voted to the amendment of paragraphs "FIRST", "SECOND" and "THIRD" of the Articles of Incorporation of said corporation as follows:

"FIRST"

"The name of the corporation is 'WESTERN AG SERVICE, INC.' "

Paragraph "SECOND" shall be amended to include as an additional paragraph thereof:

"An additional purpose of the corporation is to conduct without limitation all aspects of an agricultural business, and the corporation may also transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act."

Paragraph "THIRD" shall read:

"THIRD:

"The location and post office address of the Registered office of the corporation is Route 1, Lenore, Clearwater County, Idaho, but such registered office may be changed

from time to time by the corporation's board of directors and may be either within or without the State of Idaho."

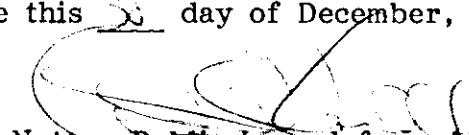
