ARTICLES OF INCORPORATION

MARKET ALL PROBLEMS

OF

PARSONS, SMITH, STONE & FLETCHER, P.A.

The undersigned, acting as incorporators of a corporation under the Idaho Professional Service Corporation Act, adopt the following Articles of Incorporation:

ARTICLE 1

NAME

The name of the corporation is Parsons, Smith, Stone & Fletcher, P.A.

ARTICLE 2

DURATION

The period of duration of the corporation is perpetual.

ARTICLE 3

PURPOSES

The purposes for which the corporation is organized are:

- Conducting the practice of law through persons qualified to practice law in the State of Idaho in accordance with the Rules of the Idaho Supreme Court and the Board of Commissioners of the Idaho State Bar governing the admission to practice law.
- Investing its funds in real estate, mortgages, stocks, 2. bonds, or any other type of investments and owning real or personal property necessary for the rendering of professional services.
- Transacting any and all lawful business for which professional service corporations may be incorporated under the Idaho Professional Service Corporation Act and the Idaho Business

AUTHORIZED SHARES

ARTICLE 4

The aggregate number of shares which the corporation shall have authority to issue is 1,500,000 common shares, each having a par value of One Dollar (\$1.00).

ARTICLE 5

QUALIFICATION OF SHAREHOLDERS

A shareholder of the corporation must be an individual who is duly licensed or otherwise legally authorized to engage in the practice of law by the Supreme Court of the State of Idaho. All shares of any shareholder who ceases to be eligible to be a shareholder of the corporation shall be sold or transferred in accordance with Article 7.

ARTICLE 6

VOTING

Each shareholder of record shall have one vote for each share of stock standing in his name on the books of the corporation. Cumulative voting for the election of directors shall be permitted.

ARTICLE 7

PURCHASE OR TRANSFER OF SHARES UPON INELIGIBILITY

Not more than thirty (30) days after any shareholder ceases to be eligible to be a shareholder, the corporation shall purchase all of the shares he owns, or such shares shall be transferred to

a person qualified, as described in Article 5. The price to be paid by the corporation and the schedule of payments shall be as specified in the By-Laws or in a stock redemption agreement.

ARTICLE 8

REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of the corporation is 137 West 13th Street, Burley, Idaho 83318, and the name of its initial registered agent at such address is William Kent Fletcher.

ARTICLE 9
