The undersigned, pursuant to the **16ab** Nonprofit Corporation Act, Article 30-3-90(2) and 30-3-93, adopts the following Articles of Amendment of the corporation.

- 1. The name of the corporation is SEICAA HOUSING 1, INC.
- 2. The amendment adopted alters Article V, Purposes, to conform with requests by the Internal Revenue Service as follows.

ARTICLE V. PURPOSES.

The purpose for which the Corporation is organized and will be operated are as follows:

- A. To provide quality affordable housing, and other charitable, religious, educational, or scientific purposes, exclusively within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under such Section 501(c)(3).
- B. To exercise all powers granted by law necessary and proper to carry out the above-stated purposes, including but not limited to the power to accept donations of money, property, whether real or personal, or any other thing of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at any time lawfully carry on or do.
