STATEMENT OF STATE
TO THE ARTICLES OF
INCORPORATION OF TELFORD
ENTERPRISES, INC.

Pursuant to the provisions of Section 30-1-61, of the Idaho Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its Articles of Incorporation:

ARTICLE FIRST

The name of the corporation is Telford Enterprises, Inc.

ARTICLE SECOND

The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on Ch. 30, 1979, in the manner prescribed by the Idaho Business Corporation Act:

Article Sixth is amended to read:

The total amount of authorized capital stock of the corporation shall be FORTY THOUSAND DOLLARS (\$40,000.00), divided into 4,000 shares of common stock of the par value of TEN DOLLARS (\$10.00) per share.

ARTICLE THIRD

The number of shares of the corporation outstanding at the time of such adoption was 3,208 shares; and the number of shares entitled to vote thereon was 3,208 shares.

ARTICLE FOURTH

The designation and number of outstanding shares of each class entitled to vote thereon as a class was as follows:

ARTICLE FIFTH

The number of shares voted for such an amendment

was 3,208 shares; and the number of shares voted against such amendment was zero.

ARTICLE SIXTH

The manner in which any exchange, reclassification, or cancellation of issued shares provided for in the amendment shall be effected as follows: No effect.

ARTICLE SEVENTH

The manner in which such amendment effects a change in the amount of stated capital, and the amount of stated capital as changed by such an amendment are as follows: Stated capital shall be increased to FORTY THOUSAND DOLLARS (\$40,000.00).
