

CERTIFICATE OF AMENDMENT  
OF ARTICLES OF INCORPORATION  
OF THE  
GOODING CO-OPERATIVE CREAMERY

KNOW ALL MEN BY THESE PRESENTS: That we, H. E. Beck, Chairman, and Kathryn Kree, Secretary, of a meeting called for the purpose of amending the Articles of Incorporation of the Gooding Co-operative Creamery, an Idaho corporation, do hereby certify and declare:

1

That two-thirds of the Directors of the Gooding Co-operative Creamery first approved the amendment hereinafter referred to to the Articles of Incorporation of said company and by a majority vote of said Directors a meeting of the stockholders of said company was called to meet on the 29th day of May, 1926 at the hour of 2 o'clock P. M. for the following purposes:

"To amend Article VI of the Articles of Incorporation of said Company by striking from said Article VI the following words;

'A holder of common stock must be the owner of at least one share of preferred stock.'"

That personal notice of the time and place of such meeting and of the object thereof was served on each stockholder at least ten days prior to the date of such proposed meeting.

That said stockholders' meeting was held in Gooding, Idaho on the 29th day of May, 1926 at the hour of 2 o'clock P. M. and that at said meeting there were present in person or by proxy stockholders representing 96 shares of the common stock of said company; that the entire common stock issued and outstanding is 146 shares and that only holders of common stock

were entitled to vote. That at said meeting, 98 shares of common stock out of a total of 148 shares of common stock outstanding and entitled to vote, voted in favor of the amendment hereinafter set forth.

That at said meeting of stockholders the following resolution was duly adopted:

"Resolved that the Articles of Incorporation of this company be amended by striking from Article VI of the Articles of Incorporation the following sentence, to wit:

'A holder of common stock must be the owner of at least one share of preferred stock.'"

We further certify that we were the Chairman and Secretary, respectively, of the meeting of the stockholders above referred to.
