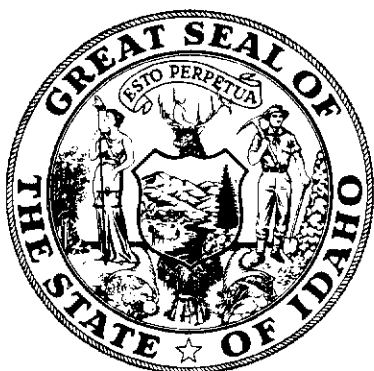

ARTICLES OF INCORPORATION
OF

WORD OF FAITH INCORPORATED

The undersigned, acting as incorporators under the Idaho Non-profit Corporation Act, hereby adopt these Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation shall be WORD OF FAITH INCORPORATED (hereinafter referred to as "The Corporation").

ARTICLE II. PURPOSE

The Corporation is organized exclusively for religious, charitable and educational purposes, including in such purposes the receipt of contributions and the making of distribution to organizations that qualify as exempt organizations under Paragraph 501(c)(3) of the Internal Revenue Code.

ARTICLE III. MEMBERS

Any person who subscribes to the tenets of faith of this church, and who is accepted by the Pastor, and who consents to be governed by the Constitution and By-Laws of the church, may become a member of the Corporation.

ARTICLE IV. LIMITATIONS OF ACTIONS

No part of the funds of the Corporation shall inure to the benefit of, nor be distributed to, its officers or directors, or other private persons, except that the Corporation shall be authorized to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes set forth in Article II above. No substantial part of the activities shall be carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in any political campaign of any candidate for public office.

ARTICLE V. DURATION

The duration of the Corporation shall be perpetual. Upon the winding up and dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for paying all of the debts of the Corporation, distribute the remaining assets of the Corporation to a non-profit fund, foundation or corporation which has established its tax exempt status under Paragraph 501 (c)(3) of the Internal Revenue Code.

ARTICLE VI. REGISTERED OFFICE AND AGENT

The location and address of the initial registered office of the Corporation shall be 4905 Industrial Ave. East, Coeur d'Alene, Idaho 83814, (mailing P.O.Box 481). The name of the initial registered agent at such address is: Carl T. Chitwood.

ARTICLE VII. DIRECTORS

The management of the affairs of the Corporation is vested in a Board of Directors who are selected under the provisions of the By-Laws.
