ARTICLE FIVE

STOCK

The aggregate number of shares which the corporation shall have authority to issue is 100 shares of common stock without par value.

ARTICLE SIX

RESTRICTION OF TRANSFER OF SHARES

No transfer of share ownership shall be valid without the prior unanimous written consent of the ownership of all issued shares. Additionally, no shareholder may sell or transfer his or her shares in this corporation except to another individual who is eligible to be a shareholder. Specifically, shareholders may only transfer or sell shares to those legally authorized to render the same or allied professional services within the State of Idaho.

ARTICLE SEVEN

DIRECTORS

All directors constituting the initial Board of Directors shall be licensed in the practice of chiropractic care.
