Know All Men By These Presents:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

First: That the name of said corporation is the Peavey-Taber Co., Incorporated.

Second: That the purposes for which it is formed are to carry on the business of lending money on farms and city property in Idaho, and of conducting a general insurance business; for the further purpose of buying, owning, renting, operating, selling, and mortgaging real estate, and of disposing of real estate in any manner.

Third: That the place where its principal business is to be transacted shall be the City of Twin Falls, Twin Falls County, State of Idaho.

Fourth: That the term for which it is to exist is fifty (50) years from and after the date of its incorporation.

Fifth: That the number of its Directors shall be three (3) and that the names and residences of those who are appointed for the first year are:
