

STATE OF WASHINGTONARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION

OF

ROSAUER'S SUPER MARKETS, INC.

## I.

The name of the corporation is ROSAUER'S SUPER MARKETS,  
INC.

## II.

The amendment adopted is as follows:

Article VI

The aggregate number of shares which the corporation shall have authority to issue is 300,000 shares of common stock with a par value of \$1.00 for each of such shares.

1. The common stock of this corporation shall be voting stock, each share of stock entitled to one vote.

2. The common stock may be issued by the corporation from time to time for such consideration in labor, services, money, or property as may be fixed from time to time by the Board of Directors; provided that said stock is issued at not less than the par value thereof; and the consent of the shareholders is hereby given to the fixing of such consideration from time to time by the Board of Directors.

3. Save as expressly hereinafter provided, the holders of said stock shall have all the rights, powers and duties as by law provided for common stock, provided that no holder of shares, as such, shall be entitled as a matter of right to subscribe for or purchase any part of any new or additional issue of stock, or securities convertible into stock of any kind whatsoever whether now or hereafter authorized and whether issued for cash, property, services by way of dividends or otherwise.

## III.

The date of adoption of the amendment by the shareholders

was January 30th 1981.

## IV.

The number of shares outstanding and entitled to vote on the amendment were 183,375.
