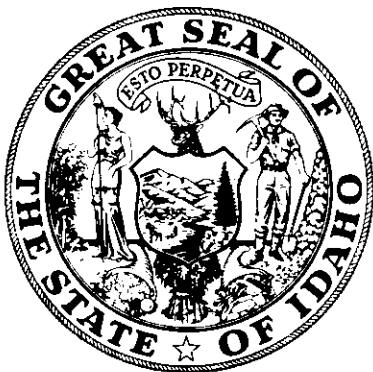

CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF

KNOW ALL MEN BY THESE PRESENTS: That at a meeting of the members of SANDPOINT AERIE 589, INC., a corporation, held at the offices of said corporation at 208 N. First Avenue, Sandpoint, Idaho, on the 17 day of JANUARY, 19~~79~~⁸⁰, and a necessary two-thirds of all of the membership being present and pursuant to a resolution duly made, seconded and unanimously adopted, the Articles of Incorporation of said corporation were amended as follows:

By adding thereto as Paragraph X the following:


