

ARTICLES OF INCORPORATION
of the

We, the undersigned, one of whom is a resident of the State of Idaho, under and in pursuance of the laws of said state, do hereby associate ourselves together for the purpose of creating a corporation with power to construct and own a railroad and franchise as hereinafter provided, and do hereby agree to and adopt the following,

ARTICLES OF INCORPORATION.

Art. 1.

The name of this corporation shall be the
"SALMON RIVER RAILROAD COMPANY".

Art. 2.

The purpose for which this corporation is organized is to construct, own, maintain and operate a railroad and telegraph line with such branch lines and extensions as may from time to time be deemed desirable and as may be authorized by law.

The said railroad and telegraph line is to begin at the town of Blackfoot on the Oregon Short Line Railroad, in Bingham County, State of Idaho, and extend thence in a general northwesterly direction to a point on Big Lost River, in or near section twenty-eight (28), township seven (7) north, range twenty-four (24) east of the Boise Meridian, in Custer County in said State, a distance of ninety five (95) miles more or less.

The total estimated length of said railroad and telegraph line is ninety-five miles and the same will be situated within the counties of Bingham, Blaine and Custer in said state.

Art. 3.

The principal place of business of said corporation shall be Pocatello, in Bannock County, State of Idaho.

Art. 4.

This corporation shall exist for the period of fifty years from the date of its incorporation.

Art. 5.

There shall be the following officers of this corporation, to-wit; five directors, a president, vice president, secretary and treasurer, and the following are the names and residences of the directors and other officers who are hereby appointed for the first year and until their successors are duly elected and qualified:
