## ARTICLES OF INCORPORATION

OF

#### THE DEEP CREEK IRRIGATION COMPANY

WE, Lynn Alder, President, and J. A. Servoss,
Secretary, respectively, of The Deep Creek Irrigation Company,
an Idaho Corporation, with its principal place of business at
Malad, Oneida County, State of Idaho, do hereby certify:

- That we are the President and Secretary, respectively, of The Deep Creek Irrigation Company, a corporation of Malad, Oneida County, Idaho.
- 2. That a Special Meeting of the Stockholders of the above corporation was held at the Malad Elementary School at Malad City, State of Idaho, on the 19th day of July, 1976, at 8:00 o'clock P.M. of said day, at which meeting more than two-thirds of the outstanding capital stock of said corporation was represented.
- 3. That said meeting was duly and regularly called and notice thereof was given as required by law and the Articles of Incorporation of said Company.
- 4. That at said meeting a Resolution was regularly proposed, voted upon and adopted by the affirmative vote of stockholders owning more than two-thirds of the outstanding capital stock of said corporation amending Article V of the Amended and Restated Articles of Incorporation of said corporation as hereinafter set out.
- 5. We further certify that the following is a full, true and correct copy of the said Article V of the Amended and

Restated Articles of Incorporation as thus amended, to-wit:

"The Capital Stock of this Corporation shall be 6,000 shares of the par value of \$300.00 for each share. Each share of stock issued and outstanding shall represent the right to share equally with every other share of stock issued and outstanding in the delivery and use of irrigation water available to the Company.

The Capital Stock of this Corporation shall be assessable to defray costs of operation and other corporate indebtedness lawfully incurred."
