## AMMENDMENTS TO ARTÍCLES OF INCORPORATION OF IDAHO DAIRYMEN'S ASSOCIATION, INC.

We, the undersigned, being President and Secretary respectively, of the Idaho Dairymen's Association, Inc., a corporation organized and existing under and by virtue of the laws of the State of Idaho, do hereby certify in accordance with the Statutes of the State of Idaho that at the regular annual meeting of the board of directors of said association, held at the Bannock Hotel in Pocatello, December 13, 1955, at the hour of 4:00 o'clock p.m., due notice having been given regarding same, at which time a quorum of the board of directors was present, the Articles of Incorporation of the association were amended by proper resolution by a unanimous vote of the directors present, said amendment to said Articles of Incorporation being as follows:

Article II, Sec. 1. Lines 14-15-16 changed to read as follows:

"The dues of the regular members (producers) shall be the sum of  $\frac{1}{2}\phi$  per pound butterfat or 2 cents per hundredweight of milk sold by said respective members during the entire year, or such other date as may be designated by the Board of Directors."

Article III, Sec. 2. "The officers of this association shall consist of president, vice-president, secretary and treasurer, all of whom shall be elected by the Board of Directors of the association at its annual meeting. All directors shall be elected for a period of three years. Five members of the Board of Directors are to be elected each year so that there will always be ten hold-over members on the Board of Directors."
