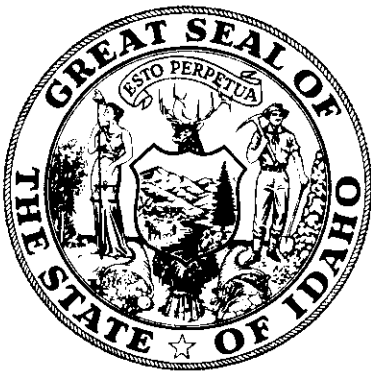

ARTICLES OF INCORPORATION--McCALL FOLKLORE SOCIETY, Inc.

A NON-PROFIT CORPORATION JAN 12 10 44 AM '81

SECRETARY OF STATE

I.

The NAME of the Corporation shall be the McCall Folklore Society, Inc.

II.

The Corporation shall be a Non-Profit Corporation.

III.

The period of duration of the Corporation shall be perpetual.

IV.

The Corporation is organized and will be operated exclusively for charitable, educational, and literary purposes, including but not limited to the promotion and preservation of folk arts and historic lore in Central Idaho.

V.

The Corporation shall have and exercise any and all powers allowed by Federal and State law for non-profit corporations.
