FIRST

The name of the corporation is

The corporation is to have perpetual existence.

THIRD

The purposes and objects for which the corporation is organized include the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act (Title 30, Idaho Code).

The aggregate number of shares which the corporation shall have authority to issue is: 50,000 (Fifty Thousand)Such shares are to consist of one class only.
