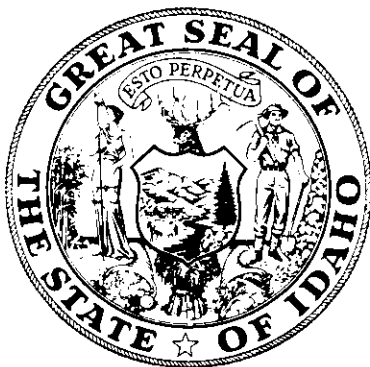


4. Adequate provision has been made for payment of all debts, obligations and liabilities of the corporation.
