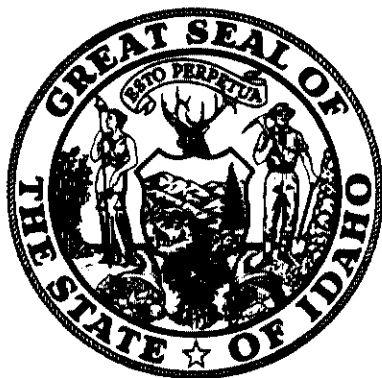
NALDER'S, INC.

ARTICLES OF INCORPORATION

The undersigned, acting as the incorporators, in order to form a corporation for the purpose hereinafter stated, pursuant to the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be NALDER'S, INC.

ARTICLE II

This corporation is formed to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The corporation is to have perpetual existence.

ARTICLE IV
