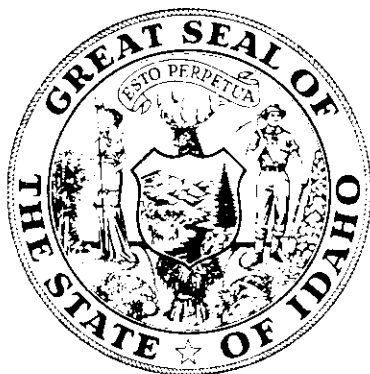

ARTICLES OF AMENDMENT
to the
ARTICLES OF INCORPORATION
of
POTLATCH TELEPHONE CO., INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Potlatch Telephone Co., Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on October 7th, 1986, in the manner prescribed by the Idaho Business Corporation Act:

1. That Article II of the Articles of Incorporation of this corporation be amended to read as follows:

"ARTICLE II. The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act."

2. That Article VIII of the Articles of Incorporation of this corporation be amended by striking out all of said Article VIII.

3. That Article IX of the Articles of Incorporation of this corporation be amended by striking out all of said Article IX.

4. That Article X of the Articles of Incorporation of this corporation be amended by striking out all of said Article X.

5. That Article XI of the Articles of Incorporation of this corporation be amended by striking out all of said Article XI.

6. That Article XII of the Articles of Incorporation of this corporation be renumbered Article VIII and amended to read as follows:

"ARTICLE VIII. The number of directors constituting the initial Board of Directors of the Corporation is four."

7. That Article XIII of the Articles of Incorporation of this corporation be amended by striking out all of said Article XIII.

8. That Article XIV of the Articles of Incorporation of this corporation be amended by striking out all of said Article XIV.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 800; and the number of shares entitled to vote thereon was 800.

FOURTH: The number of shares voted for such amendment was 800, and the number of shares voted against such amendment was zero.


