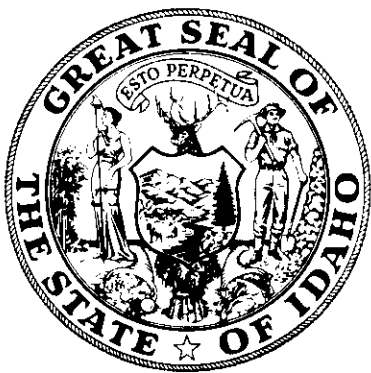

ARTICLES OF INCORPORATION

Article One: Name

The name of the corporation shall be Carole Corporation.

Article Two: Duration

The duration of the corporation shall be perpetual.

Article Three: Purpose

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated.

Article Four: Shares

The aggregate number of shares which this corporation shall have the authority to issue shall be one hundred thousand (100,000). Such shares are to consist of one class only. The par value of each such shares shall be one dollar (\$1.00).

Article Five: Pre-emptive rights

Pre-emptive rights shall not be denied to shareholders.

Article Six: Restriction on the Transfer of Shares:

A written restriction on the transfer or registration of transfer of shares of this corporation shall be noted conspicuously on all certificates representing such shares and shall read as follows:

"Restriction on tranfer of shares. The effective transfer of these restricted shares shall require the unanimous prior written approval of the holder(s) of said shares with regard to (a) the proposed transfer of the restricted shares, and (b) the proposed transferee of the restricted shares, and (c) the terms and conditions of said proposed transfer."
