

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located

at **Boise** in the County of **Ada**

and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

IDaho ASSOCIATION OF THE DEAF, INC.

KNOW ALL MEN BY THESE PRESENTS:

That WE, the undersigned, all of whom are residents of the State of Idaho, of full age and citizens of the United States, pursuant to the order of the Idaho Association of the Deaf, voluntary non-profit association of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under and by virtue of the laws of the State of Idaho.

And we hereby certify:

I.

That the Idaho Association of the Deaf, a voluntary non-profit association of the State of Idaho, through its presiding officers, caused due notice to be published and posted according to law, notifying the members of the association that at a certain time and place in the City of Idaho Falls, Bonneville County, State of Idaho, a meeting of the association would be held, at which an election would be conducted for the purpose of electing executive officers (directors) to serve until the regular biennial meeting of the association in 1961, and for the purpose of incorporating the said association under the laws of the State of Idaho. That pursuant to said notice, such meeting was held at 1525 Ponderosa Drive, Idaho Falls, Bonneville County, Idaho, on the 4th day of June, 1960, at the hour of 2:00 o'clock P.M., at which a resolution was adopted authorizing the incorporation of said association and an election was held at which the executive officers of the corporation were elected to hold office until the regular biennial meeting of said corporation in 1961, or until their successors were duly elected and

qualified. That said resolution for incorporation was unanimously passed and the following persons were unanimously elected to the offices designated by all members present and qualified to vote:

II.

That the name of said corporation shall be:

"IDAHO ASSOCIATION OF THE DEAF, INC."

III.

That the purposes for which it is formed are:

- (a) To advance the economic and social status and promote the general welfare of the deaf citizens of Idaho.
- (b) To prevent discrimination against the deaf.
- (c) To buy, own, acquire, sell, lease, rent, mortgage and hypothecate real estate and personal property, and to construct buildings and other improvements when and where necessary and incident to the furtherance of its objectives; to solicit, receive and expend, for the furtherance of its objectives, any and all gifts and donations from public or private sources, and to enter into any and all contracts necessary to conduct its affairs.
- (d) To do each and every thing necessary, suitable or proper to accomplish any of the purposes herein enumerated, or which shall at any time appear conducive to or expedient for the benefit of this corporation.

IV.

That the location and postoffice address of its registered office in the State of Idaho is the city of Boise, County of Ada, State of Idaho.

V.

That the term for which it is to exist is in perpetuity.

VI.

That the by-laws of this corporation shall be, and are, as duly passed and adopted at the biennial meeting of the Idaho Association of the Deaf, a voluntary association, in 1932, and may be amended as provided therein.

VII.

That the executive officers of this corporation shall consist of a President, a First Vice-President, a Second Vice-President, a Secretary, ^aTreasurer, an auditor and a Sergeant-at-arms, and the first six of said officers as provided in said by-laws, shall constitute the Board of Directors of this corporation.

VIII.

That this corporation shall have no capital stock and is not organized for the purpose of pecuniary gain or profit.
