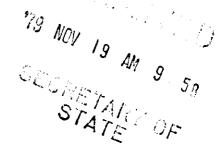

CERTIFICATE OF RESOLUTION TO DISSOLVE

DOLLARWISE, INC.

I, EMERY BORS, President of Dollarwise, Inc., hereby certify that a special joint meeting of the shareholders and directors of Dollarwise, Inc., was held on the 2nd day of January, 1979, at the 6 hour of 1:30 o'clock p.m., at the office of its counsel, Gigray, 7 Miller, Downen & Weston, 9th and Dearborn Streets, Caldwell, Idaho, 8 for the purpose of dissolving the corporation.

The meeting was duly and properly called and due and proper 10 notice given therefor, all in accordance with the By-laws of the corporation, and that at the meeting the following resolution was duly and lawfully passed:

> "RESOLVED, That the following plan of liquidation of Dollarwise, Inc., be, and is hereby adopted;

- The corporation, by its duly authorized officers, will distribute pro rata to its shareholders during the month of January, 1979, all of its assets, subject to any unpaid liabilities with the exception of a reasonable amount of cash to be retained for attorneys fees, accountants fees, and other expenses of liquidation, as well as for unascertained and contingent expenses. Each shareholder will agree to assume his pro rata share of the said unpaid liabilities and to accept his interest in the real estate and will surrender all of his stock for cancellation.
- As soon as possible after the distribution has been made, counsel for the corporation shall file a petition for dissolution of the corporation under the statutes of the State of Idaho in such case made and provided, and the officers of the corporation are authorized to execute all documents necessary in connection with the dissolution.
- Within thirty days after the date of this meeting, either counsel for the corporation or the accountants for the corporation shall file Form 966 with the District Director of Internal Revenue, Boise, Idaho, together with a certified copy of this resolution.
- Counsel for the corporation, or the accountants for the corporation shall assist those shareholders who desire to have their gain taxed as provided in Section 333 of the Internal Revenue Code of 1954, for federal income tax purposes, in preparing Forms 964 and in seeing that they are filed with the Internal Revenue Service within a period of thirty days from the date of this meeting.

5. The officers and directors of the corporation are empowered, authorized and directed to carry out the provisions of this resolution, and to adopt any further resolutions that may be found necessary in liquidating and dissolving the corporation in accordance with the expressed intent of the shareholders and directors under the plan adopted at this meeting."

I, EMERY BORS, President of Dollarwise, Inc., a corporation incorporated under the laws of the State of Idaho, hereby further certify that the foregoing is a full, true and correct copy of a resolution of the shareholders and board of directors of the corporation duly and regularly passed and adopted at a joint meeting of the shareholders and directors of the corporation which was duly and regularly called and held in all respects as required by law, and by the By-laws of the corporation, on the 2nd day of January, 1979, at which meeting all of the shareholders and board of directors of the corporation were present in person and voted in favor of such resolution and that such resolution has never been repealed or amended.
