# ARTICLES OF INCORPORATION OF GENESEE RIM RIDERS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being all of legal age, and citizens of the United States of America, have voluntarily associated ourselves and do upon the date of these presents, hereby voluntarily associate ourselves together for the purpose of forming a corporation of social, educational, benevolent and charitable character under the laws of the State of Idaho, and we do hereby adopt and certify the following Articles of Incorporation, to-wit:

#### ARTICLE I

The name of this corporation shall be 'GENESEE RIM RIDERS, INC.

## ARTICLE II

Initial registered agent and office shall be President Dwight Ferguson, Route 1, Eox 106 Genesee, Idaho 83832.

## ARTICLE III

The duration and term of existence of this corporation shall be perpetual.

#### ARTICLE IV

In furtherance, and not in limitation of the general powers conferred by the laws of the State of Idaho, this corporation shall have the following objects, purposes and powers:

To promote the breeding, training, use and care of pleasure and riding horses as an enjoyable and beneficial type of recreation; to promote interest in and further the training of young persons in the proper care and humane handling of horses; to encourage good sportsmanship among riders participating in all activities pertaining to pleasure and riding horses in recreation,

competition or otherwise; to participate in and sponsor competition and contests with members of this organization as well as with members of other and similar organizations.

To acquire, own, hire, lease and provide facilities consisting of both real and personal property, equipment, and gear for its members and in furtherance of its objects and purposes.

To do all things in connection with its objects permitted by law and to exercise any and all powers not prohibited by law as pertains to organizations of this type.

## ARTICLE V

This corporation is not organized for profit and shall have no capital stock, and shall be composed of members rather than shareholders in accordance with the foregoing provisions.

# ARTICLE VI

The conditions and regulations of membership and the rights and privileges of members shall be determined and fixed by the By-Laws.

#### ARTICLE VII

The private property of the members shall not be subject to the payment of the corporate debts, liabilities or obligations to any extent whatsoever.

#### ARTICLE VIII

The officers of this Corporation shall consist of a President, a Vice-President, a Secretary, a Treasurer, a Trail Master, and such other officers as may be provided by the By-Laws, and their qualifications, terms of office, manner of election, time, place, and manner of calling meetings and other powers and duties shall be prescribed by the By-Laws.
