ARTICLES OF INCORPORATION

of

COMMUNITY CONGREGATIONAL CHURCH OF PRIEST RIVER, IDAHO, INC.

KNCW ALL MEN BY THESE PRESENTS:

That the undersigned, all being of full age, and all being citizens of the United States of America, have associated and do hereby associate themselves together for the purpose of forming a non-profit, religious corporation under Chapter 11, Sections 30-1101 to 30-1110, Idaho Code, governing Religious, Social and Benevolent Corporations.

I.

The name of the Corporation shall be COMMUNITY CONGREGATIONAL CHURCH OF PRIEST RIVER. IDAHO. INC..

II.

The purposes of this Corporation shall be as follows, to-wit:

- 1. The worship of God and the promulgation of the Christian religion;
- 2. The support of missions:
- 3. Furnishing aid to the needy and sick;
- 4. Procuring, holding and keeping in repair a house of public worship, a parsonage, parish house and such other real estate, as may be necessary, appropriate, or desirable for the purposes herein.
- Accepting trust and holding trust funds, procuring and holding stocks, bonds, moneys, securities and other property, real or personal, all for the purposes aforesaid, at the City of Priest River, County of Bonner, State of Idaho.

III.

The principal place of business and the location and postoffice address of its registered office shall be Priest River,
Idaho.

IV.

The period of the existence and the duration of the life of this Corporation shall be perpetual.

The corporation shall be non-stock, and no dividends or pecuniary profits shall be declared to the members thereof.

VI.

The general officers of this corporation shall consist of a board of trustees to consist of seven (7) members, who shall manage the business affairs of the corporation.

VII.

The membership of this corporation shall consist of those persons signing these Articles, and such other persons who may from time to time be admitted to membership in the corporation.
