The undersigned, acting as incorporator under the laws of the State of Idaho adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is: BELLEVUE RECREATION LEAGUE, INC.

ARTICLE II

This corporation shall have no capital stock and shall be organized as a nonprofit corporation as defined by Idaho Code Title 30 Chapter 3.

ARTICLE III

This corporation shall continue in existence perpetually unless dissolved pursuant to law.

ARTICLE IV

The purposes for which the organization is formed are:

(a) To promote community involvement in recreational activities and team sports in the city of Bellevue by procuring land and improvements thereon, by applying for and receiving grants from the New Economic Development Grant Program, or any other agency or entity, and by working with the Bellevue City Council and/or any other party or entity in achieving those goals;

(b) To buy, own, acquire, sell, lease, rent, mortgage real estate and to construct buildings and other improvements when and where necessary and incident to the furtherance of its objects, and to enter into any and all contracts necessary to conduct its affairs;

(c) To do each and everything necessary, suitable or proper for the accomplishment of any of the purposes and objects herein enumerated; or which shall at any time appear conducive to or be expedient for the benefit of this corporation.

ARTICLE V

This corporation shall have members and the management of its affairs it to be vested in its board of directors pursuant to section 30-314(a) of the Idaho Code.
